Thank you for allowing Baymeadows Movers to provide for your storage needs. Please review the following terms and conditions regarding your storage.

Warehouse Agreement Terms and Conditions:

1. OWNERSHIP OF PROPERTY: The customer has represented and warranted to the company that he/she is legal owner or in lawful possession of the property and has legal right and authority to contract for services for all property tendered, upon provisions, limitation, terms and conditions herein set forth and that there are no exiting liens, mortgages, or encumbrances on said property. If there by any litigation as a result of the breach of this clause customer agrees to pay all charges that may be due together with such costs and expenses including attorneys fees which this company may reasonable incur or become liable to pay in connection therewith and this company shall have a lien on said property for all charges that may be due them as well as for such costs and expenses..

2. PAYMENTS: I understand that storage fees are due upon receipt of invoice, and I will receive an invoice by mail or email each month. It is agreed that the company shall have a general lien upon any and all property deposited with it or hereafter deposited with it. All goods deposited upon which storage and all other charges are not paid when due, will be sold at public auction to pay said accrued charges and expenses of the sale, after due notice to the depositor, and publication of the time and place of said sale, according to law.

3. DELIVERY OUT FROM STORAGE: When I am ready for my goods to be delivered out of storage, I agree to provide a minimum of seven (7) days advance notice. This notice can be by phone, mail, email or fax. At the time of my request, I agree to provide the delivery address with zip code, as well as a phone number where I can be reached.

I understand that any outstanding balance must be paid in full before release of my furniture. I understand that labor for delivery out is a separate charge, and must be paid at time of delivery.

4. WAREHOUSE ACCESS: Warehouse access is by appointment only. We request a minimum of 72 hours advance notice. You will be charged \$45 per hour per man for warehouse access, one hour minimum.

5. LIABILITY OF THE COMPANY: (a) No liability of any kind shall attach to this company for any damaged caused to the goods by inherent vice, moths, vermin or any other insects, rust, mildew, fumigation or deterioration.

(b) Unless a greater valuation is stated herein, the depositor or owner declares that the value in case of loss or damage arising out of storage, transportation, packing, unpacking, fumigation, cleaning or handlings of the goods .60 cents per lb. per article.

(c) In no event shall the company be responsible for loss or damage to documents, stamps, securities, specie, jewelry or other articles of high and unusual value unless a special agreement is made between the customer and the company with respect to such articles.

6. CHANGE OF ADDRESS/PHONE: I shall provide Baymeadows Moving and Storage with a current billing address and phone number(s) where I can be reached while my items are in storage. It is agreed that the address of the depositor of goods for storage is as given above, and shall be relied upon by the company as the address of the depositor until change of address is given in writing to the company.
